## CHAMPIONSHIP ADJUDICATING PANEL (CAP)

The CAP is chaired by Tecnical Delegate Martin Wren and includes Championship Director Poku Salo and Championship Referee Jyrki Wahlstedt.
The CAP will scrutinize nominations and will consider any objections lodged with the Championship Director.

The CAP reserves the right to amend any squad order without formal objection. They will hear all appeals and will be responsible for adjudicating on all on-site Championship matters.
The decision of the CAP will be final.

## REGULATIONS

The Championships will be run in accordance with the rules governing the ETC.

## CHAMPIONSHIP OFFICE

There is a Championship Office both at the Talihalli and the Esrport Center. They will be open every day from 09:00 until 30 minutes after the last match is finished.

## ARRIVAL SERVICE

On arrival day the 25th of April there will be a person at both terminals at the airport meeting the groups and directing them to the buses.

## INFORMATION DESK

The Information Desk is located at Holiday Inn on Tuesday 25th from 16:00-21:00 and daily during playing hours at both venues in connection with the Championship office.

## PRESS OFFICE

A Press Office is located at the venues and will be available to the press during playing hours. boards.

## ACCOMMODATION

The package fee covers accommodation and meals for players, managers, coaches and supporters as submitted on the entry forms.
All additional rooms and rooms booked for other nights must be paid for by the occupants.
All participants must settle the bill for all their extras at the hotel reception before departure.

## TRANSPORTATION

There will be a shuttle bus from the hotels to the venue regularly.
The first bus leaves every morning from Holiday Inn 90 min before the
start of the daily matches. The last bus from the venue leaves 60 min after the last matches or when everybody is ready to leave the venue. A schedule for the transportation covering all days will be posted on the information boards.

## BADGES

Every participant, coach, manager, supporter and volunteer will be supplied with a badge. You will be required to wear this badge visibly throughout the
Championship. If you lose your badge, you must report this to the Championship Office immediately.

Lost meal vouchers WILL NOT be replaced.

## COST INCURRED

All players and officials will be responsible for all extras incurred at the hotel and venue.

## THE CHAMPIONSHIP AND RELATED INFORMATION

Division 1 (men \& women) consists of the top 8 teams from last year's Championships. The men's Division 2 consist of teams that finished 9th to 20th and the women's Division 2 of teams that finished 9th to 16th + the host team.

Division 1 (men \& women) first stage will be a round-robin of four teams in each pool. In the second stage the top two teams of each pool will play the semi-finals on a knock-out basis. The other four teams will play a round-robin with results from the first stage pools carried forward.

Division 2 (men) first stage will be in pools of three teams. In the second stage top two teams of each pool will play the quarter-finals on a knock-out basis. The other tree teams play a round-robin.
Division 2 (women) will play a in two pools with the top two teams of the pools will play the semi finals on a knock-out basis.

## SQUASH BALL

The Dunlop PRO XX ball will be used for all matches. The white ball is used on the glass court.

## TEAM MANAGERS MEETINGS

The Team Managers meeting will be held at Holiday Inn on Tuesday 25th April at 20:00.

## REFEREES MEETING

A referees meeting and workshop will be held on Tuesday 26th April at Holiday Inn starting at 18:00.

## NOMINATIONS / TEAM AND SQUAD ORDERS

The Championship Director will publish all squad orders seven days before the start date on the event website www.squash.fi/?page_ id=19248 and send copies by email to all competing MNA's.
Objections to player eligibility or playing order must be lodged in writing and justified with evidence five days before the start date. Any objection to playing order must be based on latest PSA top 100 / WISPA top 50 rankings, current National Rankings or results of latest National Championships.
The CAP will scrutinize nominations and reserves the right to amend any squad order without formal objection. The CAP will consider any objection lodged with the Championship Director.
The responsible Team Manager will be advised at least two days before the start date if his squad order is subject to objection or amendment or if he is required to justify player eligibility to the CAP. In this case he must be available between 18:00 and 22:00 hours on the day before the start date to give evidence to the CAP if required. The CAP will hear his justufication with the objecting manager(s) invited to be present. The decision of the CAP will be final and will be announced by 22:00 hours on the day before the start date. Written details of the decision will be provided to Team Managers involved in the objection.

All Team Managers will be adviced if any squad is changed. All squad orders approved by the CAP will be displayed in the Championship Office.
The squad order must be adhered to throughout the Championships. Any player can be omitted from a Tie provided the others play in the order of merit approved by the CAP.
Unless the Championships Director is notified otherwise in writing at least one hour before the scheduled start of a Tie or within 10 minutes of completion of the previous Tie (whichever is the later),
Managers shall be deemed to have selected their top 4 men or top 3 women players.
The CAP reserves the right to allow changes to player nominations after the deadline for each Tie in exceptional circumstances.
A Team Manager may request permission from the CAP to replace a member of his squad at any time after the Final Submission Date and through the
Championships. Such permission will only be given if the reason is considered by the CAP to be legitimate (e.g. illness, injury or force majeure) and provided that the replacement player is accepted by the CAP as being of lower strength than all members of the squad previously nominated.
The Championships Director will advise all Team Managers in writing if a player is being replaced. Any appeal against the decision to replace or not replace a player during the Championships must be made within two hours to the CAP.
All player privileges and facilities will be passed on to any replacement player, on arrival at the Championships, by the player being replaced; and the replaced player may not rejoin his squad during the Championships.

## CLOTHING REGULATIONS

The WSF clothing and advertising regulations will be adhered to. In all matters of judgment or opinion arising from the interpretation of the regulations, the decision of the Championships Referee shall be final, except that he may not rule illegal or unacceptable an item or a design which has been approved by the WSF.
The sponsor(s) of the Championships shall have no automatic right of exposure on players' clothing unless such exposure is stipulated on the Entry Form and with the approval of the ESF Officers. MNAs are advised to ensure that their contracts with individual players specify that
players' personal sponsors have no right of exposure on such kit. Where the manufacturer of clothing is also the sponsor of the player or team wearing the clothing, he shall additionally be allowed to utilise some or all of the advertising space granted to sponsors.

## PLAYERS ON COURT

It is the responsibility of each team to be ready to play at the advertised start time of the Tie. Every nominated player must be present at the venue at the start time for the Tie.

## RACKET STRINGING

There is a stringing service available at the venue for the entire event. This service is at the player's own expense. For more information please enquire at the Information Desk.

## PRACTICE COURTS

A limited number of practice courts can be booked at the Championship Office at each venue.

## SQUASH BAGS

All squash bags should be kept under own supervision at all times. No responsibility can be accepted for loss or damage to personal items.
Please do not leave any belongings in the changing rooms.

## MEDICAL

Medical staff will be present at the venue at all times. In case of medical emergencies and/or accidents, please report immediately to the Information Desk. They will notify the proper authoriiyies, if necessary.

## TEAM PHOTOGRAPHS

Teams may have their photographs taken by the official photographer, who will be present daily. The pictures can be purchased at own expense.

## NEWS \& COMMUNICATION

## Information boards

The Championship's offical information board will be located at the venue. There will also be an "unofficial" information board at the hotels. Participants are asked to check the boards on a regular basis for updated news.

## Team's mail boxes

Mail boxes for each team are situated at the venue next to the Championships Office. For smooth running of the Championships, we ask Team Managers to empty their boxes regularly.

## OPENING CEREMONY

The official opening ceremony will be held at the Talihalli Glass Court on Wednesday 26th April at 09:30 hours.

## MEDAL AWARD CEREMONY

The official medal award ceremony for the Championships will take place on the Talihalli Glass Court following the completion of the finals on Saturday April 29th.
Players and team managers for the top three teams in both Division 1 and Division 2 are expected to be present wearing team tracksuits.

## FINALS DINNER AND PARTY

The Championships finals dinner for players and officials will be at Hotel Holiday Inn.

## RULES GOVERNING THE CHAMPIONSHIPS

Definition
Ties are between opposing teams, matches are between individual players.

## Team management

Upon arrival at the Championships the Team Manager shall be the official and sole representative of their team in all matters, exept when an individual match has started, when the Rules of the Game shall apply. At all other times, the team manager shall act for all members of their team in receiving and giving instructions.

## Responsibility

Players enter and play in the Championships at their own risk. Neither the ESF, the Host Association nor the Host Club will accept any responsibility for injury or other damages arising from participating in the Championships. Players may be required to sign a disclaimer to this effect.

## Doping testing

The ESF and the Host Association reserve the right to implement compulsory doping testing for any player participating in the Championships. The doping regulations shall be those published by the WSF.

## Championship timetable

1. Ties shall be played on a maximum of two courts per tie.
2. All ties shall be played over a period not exceeding four days.
3. The playing schedule shall be organised, where possible, to ensure that all teams have an equal rest period between ties. (The period from the start of the first tie to the start of the last tie in a Pool shall be similar for all teams in that Pool.)
4. Teams may be required to play two ties per day, in which case there shall be a minimum of four hours between the scheduled start times of each tie.
5. Both semi-final ties shall take place on the same day.
6. Each final shall be scheduled to commence at least 18 hours after the start of the latest relevant semi-finals.

## Final order of teams

1. The following are scored by each team:

Tie Points for each tie -2 for a win, 1 for a draw, 0 for a loss
Match Points for each Match won in the Tie
Game Points for each Game won in each Match
Single Points for each Point won in each Game.
2. The final places in a Pool shall be decided on all the results of that Pool:
a. first by the greater number of ties won; b. if 2 or more teams have won the same number of ties, then by the greater number of Tie Points won;
c. if 2 or more teams are still equal, then by the greater positive difference of Match Points won and lost; four days.
d. if 2 or more teams are still equal, then by the greater positive difference of Game Points won and lost;
e. if 2 or more teams are still equal, then by the greater positive difference of Single Points won and lost;
f. if 2 or more teams are still equal, the result of the match(es) between the \#1 players (in order of games then points) of the Tie(s) between them;
e. if 2 or more teams are still equal, then by the greater positive difference of Single Points won and lost;
f. if 2 or more teams are still equal, the result of the match(es) between the \#1 players (in order of games then points) of the Tie(s) between them;
g. if 2 or more teams are still equal, the result of the match(es) between the \#2 players (in order of games then points) of the Tie(s) between them;
h. if 2 or more teams are still equal, the result of the match(es) between the \#3 players (in order of games then points) of the Tie(s) between them.
3. At any knockout stage, the result of a Tie between two teams shall be decided:
a. by the greatest number of matches won;
b. if equal, by the greatest positive difference of games won and lost;
c. if still equal, by the greater positive difference of oints won and lost;
d. if still equal, by the result of the match between the \#1 players of the Tie.

## Playing order of matches in Ties

1. The playing order of matches in all Ties on each day of the Championships will be drawn by the CAP at the Tream Managers meeting; and shall be posted in the Tournament Office and in the official hotel. All Ties played each day will use the same playing order (but can vary from day to day).
In men's Ties, if 3 or 4 matches are played on one court, the $\# 1$ must play 2 nd on that court. If only two matches are played on a court the \#1 player must play 1st on one court. The playing order of all other matches will be drawn against 6 possible permutations.
In women's Ties, the \#1 must play 1st or 2nd with the playing order of all other matches being drawn against 4 possible permutations (1-2-3, $1-3-2,2-1-3,3-1-2)$. In mans ties
2. Players will be required to complete all matches in a Tie even if the result of the Tie has already been decided except in the Men's Final when, if both Managers agree, the following will apply:
If the result of the Tie has already been decided on count-back before a Match commences, then that Match will not be played and the result will be recorded as 'unplayed'

If the result of the Tie becomes decided on count-back whilst a Match is in progress, then play will cease at the end of the current Game and the result will be recorded as 'unfinished'
A Tie is decided on count-back in line with Rule J3 only if the result of the Tie cannot be changed however many more matches, games or points are played in that Tie
If the Managers do not agree, the match will be played in line with Rule H1.
3. The Team Manager and all members of his team for that specific tie must be at the designated court(s) ready for the scheduled start of the tie. If the whole team fails to arrive within 10 minutes of the scheduled start time or within 10 minutes of the first court becoming available for that Tie (if later), the Tie shall be conceded with the Team earning no Tie, Match, Game or Single Points.
If a member of the team fails to arrive within 10 minutes of the scheduled start time or within 10 minutes of the first court becoming available for that Tie (if later), the player must be replaced by the nominated member of the team ranked immediately below this player. The "bottom" match in the Tie shall be conceded.
Any player not on the designated court and ready to play within 10 minutes of the completion of the preceding match in the Tie will be scratched. If after another 10 minutes the next scheduled player is not on court ready to play that player also will be scratched. In this instance, all matches lower in the playing order, will be forfeited.
The Team Manager has the right of appeal to the CAP in the event of force majeure.

## Scoring

All matches are PAR-scoring to 11 points.
